TEMPORARY RESTRAINING ORDER

Before the Court is Plaintiff, Monique Rathbun's Petition for Temporary Restraining Order against David Miscavige, Religious Technology Center, Church of Scientology International, Steven Gregory Sloat, and Monty Drake ("hereinafter collectively referred to as "Defendants"). The Court has considered the papers filed, the evidence presented and arguments provided, and rules as follows:

The Court finds that Plaintiff has met all of the requisites for a temporary restraining order based on the moving papers and supporting Affidavits. The Court finds that Plaintiff has established (1) likelihood of irreparable harm and the unavailability of an adequate remedy at law; (2) a substantial likelihood of success on the merits; (3) the threatened injury to Plaintiff outweighs any possible harm to Defendants; and (4) that the granting of this temporary restraining order will not disserve the public interests.

IT IS THEREFORE ORDERED THAT Defendants and any of their agents, servants, employees, and attorneys, and those persons acting in concert with them, cease and desist from harassing and invading the privacy of the Plaintiff, Monique Rathbun.

Specifically, Defendants and their agents, servants, employees, attorneys and those in

active concert or participation with them are restrained and temporarily enjoined from performing or engaging in any of the following acts pending a hearing on Plaintiff's motion for temporary injunction:


1. Electronic or personal surveillance of Mrs. Rathbun's home, her workplace, or her public activities.
2. Making threats to Mrs. Rathbun in person or by telephone or electronic means.
3. Following, pursuing, stalking, or "tailing" Mrs. Rathbun.
4. Contacting or harassing Mrs. Rathbun's employer, her co-workers, her family members, or her friends.

IT IS FURTHER ORDERED, THAT a temporary injunction hearing is ordered set in the _____ District Court of Comal County, Texas, at the Comal County Courthouse, for the 27 day of August, 2013, at 9:00 a.m./p.m.






